WISCONSIN DNR REGULATIONS FOR HVAC COMPANIES

In May, 2006, the Department of Natural Resources (DNR) sent a postcard to all parties holding a "HVAC Contractor" credential issued by the Commerce Department under COMM 5, Wis. Adm. Code. The purpose of that mailing was to inform HVAC businesses that you may also be regulated when handling "end-of'-life" equipment.

In 1990, Wisconsin enacted laws to prohibit the release of refrigerants that destroy the earth's protective ozone layer. Since that time, other damaging refrigerants have been added to these regulations. As refrigeration and air-conditioning equipment is being serviced or disposed, these substances cannot be released – they must be properly recycled using approved equipment operated by qualified technicians.

The 1990 laws created three regulatory programs housed in three state agencies: The Department of Agriculture, Trade and Consumer Protection regulates anyone who services vehicle airconditioners and refrigerated transport under ch. ATCP 136, Wis. Adm. Code. The Commerce Department regulates those who install and maintain "stationary" refrigeration and AC equipment under chs. COMM 5 and 45, Wis. Adm. Code.

THE DNR REGULATES SALVAGE ACTIVITIES The DNR regulates those who transport or salvage any type of refrigeration or air-conditioning equipment containing regulated refrigerants and which has been permanently removed from service BADGERAIRE June, 2007

and is intended for disposal or salvage. The requirements are spelled out in ch. NR 488, Wis. Adm. Code, "Refrigerant Recovery from Salvaged and Dismantled Refrigeration Equipment."

An HVAC companies' work comes under these regulations if they handle refrigerated home appliances to be recycled. HVAC contractors may also come under the regulations when replacing a complete home AC system or when hired by a demolition contractor to recover refrigerants from equipment in a building.

SUMMARY OF DNR REGULATIONS

Chapter NR 488 strictly prohibits releasing "regulated refrigerants" (CFC, HCFC, HFC and PFC refrigerants or blends) while salvaging or dismantling whole units of any type of refrigeration or air-conditioning equipment or transporting it for salvage. They must be properly recovered, using approved equipment operated by qualified technicians. The business recovering these refrigerants must be registered with the DNR, keep records of their recovery activities, and supply documentation that the refrigerants were properly removed to whoever receives the scrapped equipment (only one-time-per scrap business). Those transporting appliances for salvage that contain regulated refrigerants must certify to the DNR that they will not release those refrigerants during this "Safe Transport."

The rule sets annual registration fees for those who perform refrigerant recovery or safe transport, and states the statutory penalties for violations of several provisions. The usual DNR registration fee for HVAC companies is \$125 if they are registered with the Commerce Department and only salvage as a minor activity incidental to providing repair services.

ASHRAE's new 2007 ventilation standard contains key changes impacting ventilation system designers and their designs.



"Changes in the 2007 standard build on the improvements published in the 2004 version, providing additional guidance for designers of building ventilation systems."
