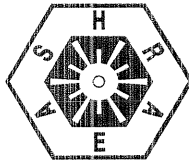

Join us for our meeting to see how you can benefit your company or clients by participating in these energy conservation programs.

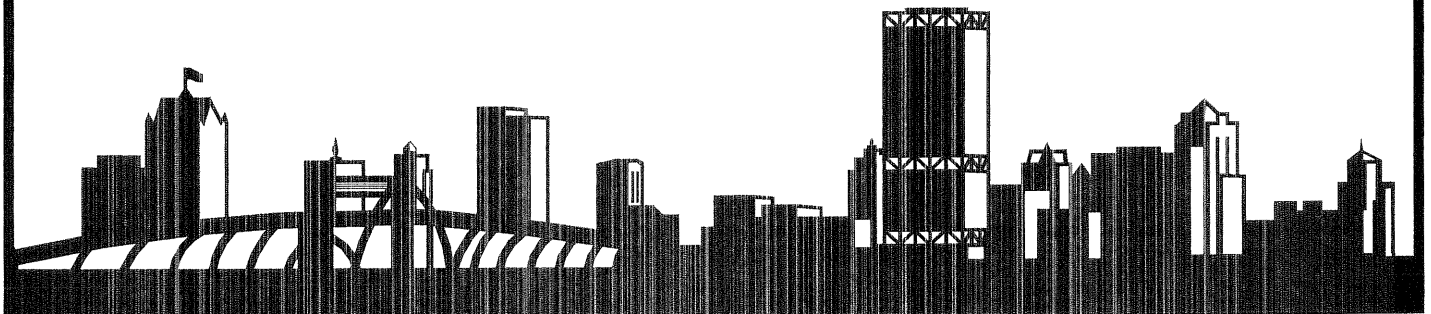

Various steam customers use high and low pressure steam from the plant for building heat, domestic water heating and process heat. For those of you who hear the words "cogeneration" and have a foggy notion of what it all involves this is a good chance to see it in action. As opposed to a gas fired cogen plant utilizing combustion turbines, this plant burns coal to produce both electricity and usable heat.
